Terms and Conditions for “Pianoschool Daan van Schaik,” Buurthuis Zilst, Veldhoven

-Registration is completed by filling out the registration form (click on the word “registration form”). By registering, you agree to these terms and conditions.

-All prices are exclusive of VAT. (21 years and older is subject to 21% VAT; under 21 years is VAT-exempt)

-Tuition fees are paid monthly based on an invoice.

-There is a 1-month notice period. For example: If you cancel on May 1, lessons will continue through June 30. If you cancel on May 30, lessons will also continue through June 30.

Cancellation must be made in writing by sending an email to Daanvanschaikmusic@gmail.com. (The notice period does not apply to a try-out lesson or a 5 lesson trial package.)

– A try-out lesson and/or trial package may only be taken once per student.

– In the event of late payment, Pianoschool Daan van Schaik reserves the right to suspend participation in lessons, without thereby waiving the payment obligation. Once the payment obligation has been fulfilled, lessons may resume. Missed lessons will not be made up. If a debtor fails to meet their payment obligation, we will refer the collection to an external agency, with any costs incurred and statutory interest being the responsibility of the debtor. In the event of late payment, Pianoschool Daan van Schaik may refuse registration for a follow-up course.

-If a student cancels a lesson due to illness or for any other reason, the lesson will not be rescheduled and will still be charged.

-If the teacher is ill or absent, the lesson is canceled and will not be charged.

-In general, lessons follow the elementary school calendar. This means there are no lessons during school holidays. However, piano lessons do take place on school study days or other school-specific days off.

-Lessons are held on Wednesdays between 1:00 PM and 6:00 PM in the Runzaal at Buurthuis Zilst. The specific lesson time is determined by mutual agreement.

-To ensure the continuity of lessons, the lesson room is reserved well in advance. If the piano room is unavailable, we will, in consultation, reschedule to another day or make up the lessons in another way (e.g., double lessons). If these options are not possible, the lesson will be canceled.

-There are no piano lessons during the first week after summer break. This week is used to gather students' availability and create a schedule. Piano lessons then begin in the second week after summer break.

-Pianoschool Daan van Schaik assumes no liability whatsoever for loss, theft, or damage to the student's personal belongings during lessons, or while traveling to and from lessons. Pianoschool Daan van Schaik is also not liable for any personal injury caused during lessons.

-Email addresses and phone numbers of students and/or parents/guardians are used solely for informational purposes and are not shared with third parties. Personal data of students or parents is also not shared with third parties. The only exception to this is in the event of overdue payments.

-Pianoschool Daan van Schaik reserves the right to use audio and/or video footage of students for its own promotional purposes (its own website and social media channels). If you object to this in advance, we ask that you notify us immediately at the start of the course by indicating this on the registration form.

-It is not permitted to record video and/or audio during lessons without the permission of Pianoschool Daan van Schaik.
